TERMS & CONDITIONS

1. The promoter is “KWV VS Brandy” (A brand under Warshay Investments Pty (Ltd), Registration no 2012/018 792/07 ta KWV). Referred to as “the Promoter”.
2. By participation in the KWV VS Brandy, Win a Limited Edition Vinicius Jr. Golden Concept Watch Cover (“the Competition”), participants agree and accept the rules set out below. Entry in the Competition constitutes acceptance of these rules.
3. The participating products include KWV VS VERY SPECIAL POTSTILL BRANDY.
4. This offer may not be used in conjunction with any other offer of the Promoter.
5. The Competition starts on 1 October 2023 and ends on 31 December 2023. Any entries received after the closing date of 31 December 2023 will not be considered, regardless of the reason for the late receipt of the entry.
6. The Competition is open to all persons of 18 (eighteen) years or older and resident in South Africa. A copy of a participant’s identification document (ID) is required in order to be validated as a winner of the Competition as provided for in paragraph 13 below.
7. The following persons shall not be eligible to participate in the competition:
 - 7.1. a person younger than 18 (eighteen) years;
 - 7.2. a director, member, partner, promotional or advertising agent, merchandiser, employee or consultant of the Promoter or any other person who directly or indirectly controls or is controlled by the Promoter, or an organiser of the Competition;
 - 7.3. a supplier of goods or services in connection with the Competition;
 - 7.4. a person who are not a legal resident or citizen of the Republic of South Africa;
 - 7.5. a spouse, life partner, parent, child, brother, sister, business partner or associate of any of the persons specified in paragraphs 7.1 to 7.4 above.
8. The Promoter may not award a prize to a winner of the Competition if it is unlawful for the Promoter to supply such a prize to that person.

10. To enter, Entrants will be required to:
- a. Purchase a bottle of KWV VS VERY SPECIAL POTSTILL BRANDY (750ml) and upload their till slip or receipt as their proof of purchase
 - b. Scan the QR code on a KWV VS competition neck-tag

 - d. Submit your personal details i.e. full name, ID number, contact number, email address, physical address and date of birth
11. Participants may enter the Competition unlimited times over the promotional period, provided that the participants purchase the participating products each time they enter the Competition and comply with the Competition rules, subject to the following conditions:

 - 11.1.2. Each new entry is accompanied by a unique till slip
12. Winners will be selected by means of a random draw by 17 January 2024 and will be notified telephonically where the winner will be required to verify their details. The Promoters (or their agent) will endeavour to contact the prize winner once every day for 5 consecutive working days after their name is drawn. If the prize winner cannot be contacted during this period, the prize will be forfeited and another winner will be selected in accordance with the rules.

Winners will be required to sign acceptance of prizes and indemnity documents.
